



The above squads shall have vigil at all times on all days by rotation as specified and take action if they notice any incidence of ragging either in the Campus, oversight and patrolling the University and the common areas in the academic/administrative/hostel/ness of the University. They will remain mobile, alert and active all the time and are empowered to inspect places of potential ragging and make surprise raids on hostels and other hotspots inside and outside the university campus. The Squads will also have the responsibility wherever required to investigate incidences of ragging and make recommendations to the Anti-Ragging Committee for immediate action. On the report of Anti-ragging Squad or any other person who is the witness of the incidence of ragging or on the complaint of any fresher student, immediate action will be taken by the Anti-Ragging Committee to decide appropriate punishment from the list of punishments prescribed under the Rules and award it.

During day hours, Deans of respective colleges shall be responsible to check the ragging in the college premises. Security officer will make all necessary arrangements by instructing their staff posted at various security points, to be more alert and vigilant to check the ragging in the campus. In hostels respective Chief Wardens and Wardens shall be responsible to check in ragging.
